Terms and Conditions

1. Sealed Tenders are invited from interested parties for cutting of trees at Angamaly KSIDC- . Business Park, Ernakulam.
2. The trees numbered are available at the project site for inspection. The list of trees are available at KSIDC Office , Kochi
3. The trees can be inspected on any working day between 10.00 a.m. and 5.00 p.m. after contacting 0484 232 3010
4. Necessary tax as applicable shall be paid by KSIDC.
5. The tender (Annexure II) should be kept in a separate sealed cover. The tender form, EMD and documents mentioned in Para **12** should be put in a separate cover. These covers should be then put together in a common cover super scribed with **“Tender for disposal of trees marked at site.”**
6. Those who wish to participate in tender should also submit the tender form duly filled and signed and attach all the documents as specified in Para 12 along with EMD.
7. The sealed tenders should be dropped in the office of KSIDC Ltd at 2nd Floor. Choice Towers, Manorama Junction, Kochi, Kerala 682016, before 2 P.M on 20.07.2017
8. The tenders bids not fulfilling the above norms will be summarily rejected without assigning any further reasons.
9. Tender forms received after the due date and time will be summarily rejected.
10. Those tenders found unsigned by the bidders and defective for other reasons are liable to be rejected.
11. The decision of KSIDC shall be final and binding to all participants.
12. The bidders participating in the tender shall attach copies of the following along with the tender / application:
 - a. Copy of Photo Identity Card.
 - b. Copy of EMD
13. **Procedure:** The tenders in sealed covers shall be opened at 2.10 P.M. The highest

offer is derived from the tender

14. The EMDs of all the bidders except highest two bids will be released from the office of KSIDC Ltd, at Kochi ,after opening the tender. **The original of the photo identity card shall be produced for refund of EMD.**
15. After satisfactory completion, the EMD shall be released to the successful bidder. No Interest shall be paid for the EMD.
16. The successful bidder shall remit the amount within 4 working (Bank) days from the date of bid opening. All payments are to be made in the form of account payee Demand Draft drawn in favour of the, KSIDC Limited payable at Ernakulam, Kerala. **The time period for the removal of entire trees shall be 30 days.**
17. After the remittance of full amount of the bid, and immediately on confirmation from KSIDC Ltd., the bidder shall acquire his/her lien on the trees awarded to him and its safety shall be his duty/responsibility from any damage or pilferage, fire or any other unforeseen calamity and no claim whatsoever on this account shall be entertained by KSIDC Ltd.
18. In case the successful bidder fails to remit the bid money in full on the stipulated date, the KSIDC Ltd. shall be at liberty to forfeit the EMD in full. The tenderer shall have no claim on such money forfeited.
19. The KSIDC Ltd. reserves the right to reject any or all the offers without assigning any reason whatsoever.
20. In case of dispute, the decision of the KSIDC Ltd. shall be final and will be binding upon the bidder.
21. All these conditions listed hereto shall be binding on the bidder, in token of which the bidder will sign all pages of this tender form.
22. The items should be removed from site within **30 days** after confirmation without causing any damages to the other properties of KSIDC Ltd.'s/others' properties. If any damages occur the cost of rectification/damage shall be borne by the party.
23. The scope of the buyer shall include only the trees marked for disposal at site.

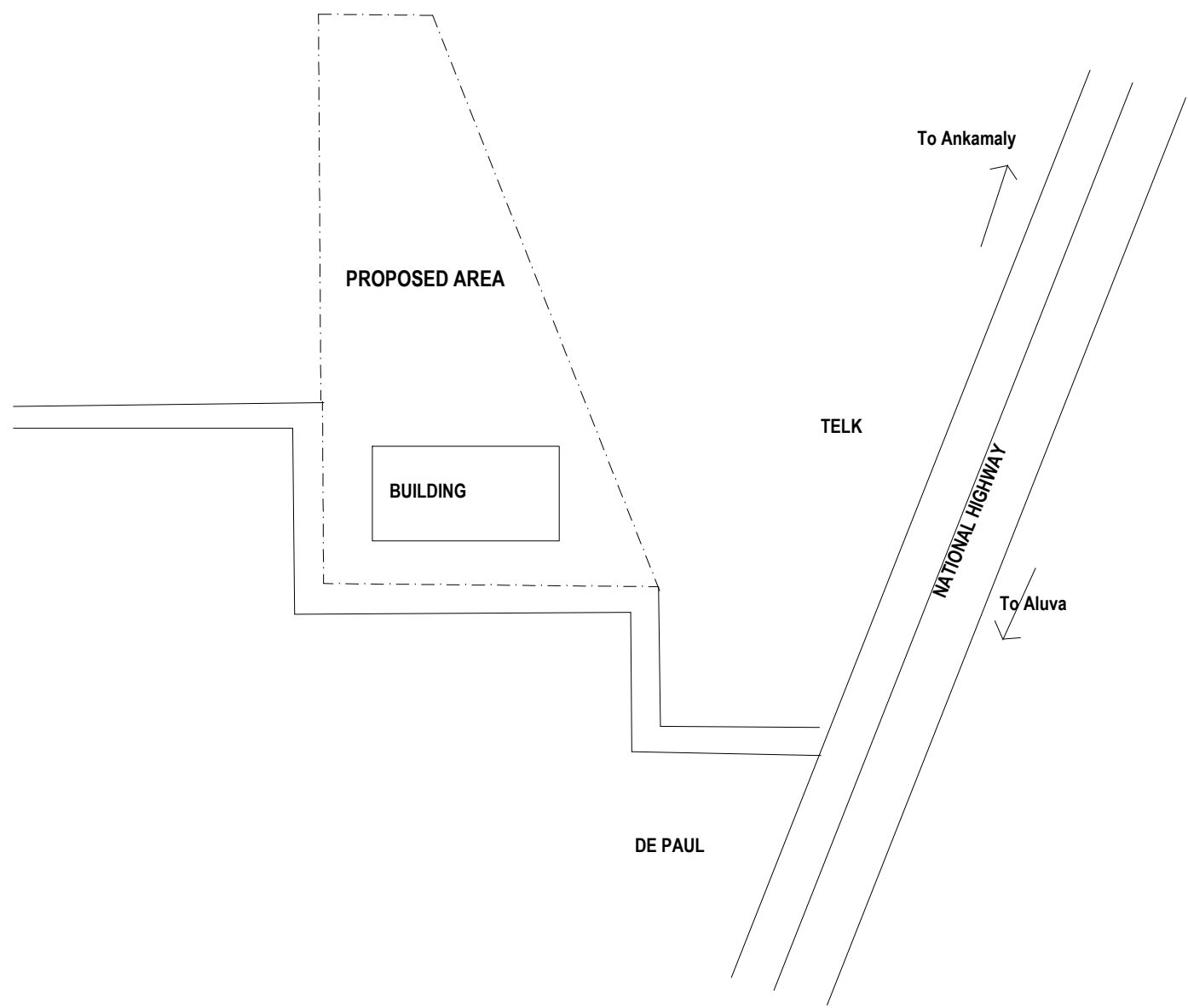
