

## NOTICE INVITING EXPRESSION OF INTEREST THROUGH E-TENDER

Tenders are invited through electronic tendering system from reputed consultants to conduct market assessment for laboratory animals in India as part of establishing Animal House at Life Sciences Park, Thiruvananthapuram as per the details given below:

Tenders shall be in 2 bid format – Technical bid and Priced bid. The EoI document is available in e-portal site [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). The technical bid and financial bid shall be uploaded separately.

Tender documents can be accessed through website [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in) on payment of Rs 2500/- plus GST@ 12%. The Earnest Money as specified for the assignment shall be remitted on-line.

The tenders can be submitted through online up to 04.04.2018 at 3.00 pm. The Pre- bid meeting shall be on 21.03.2018 at 11.00 AM at KSIDC, Thiruvananthapuram office. The technical bids will be opened on 06.04.2018 and date of opening of financial bid will be intimated to the eligible bidders. The bids will be opened at Kerala State Industrial Development Corporation Ltd (KSIDC), Keston Road, Kowdiar, Trivandrum, Kerala -

695003, in the presence of the tenderers or their representatives who may wish to be present.

The price bid of bidders who fulfills the conditions in technical bid shall only be opened.

The bidders will have to deposit an amount of Rs. 25,000/- at the time of submission of tender as earnest money. KSIDC is not liable to pay any interest on the Earnest money. The Earnest money of the unsuccessful tenderers will be refunded without any interest soon after the execution of agreement by the successful tenderer or after the expiry of the validity period of the tender. The successful tenderer to whom the contract is awarded will have to deposit as initial security deposit, a further sum to make up 5% of the value of the accepted tender including the Earnest money. Thus the total security Deposit, including the EMD, shall come to Rs. 50,000/- ( Rupees: Fifty Thousand only). The security deposit will have to be made within 14 days from the date of acceptance of tender, failing which KSIDC at his discretion may revoke the letter of acceptance and forfeit the earnest money deposit furnished along with the tender. The said amount will be kept as Performance Guarantee and the amount without any interest shall be refunded after successful completion of the assignment.
