### **Order No Stat 3A /78473/DHS/2020 Dated 07-12-2020**

As per the letter cited 4<sup>th</sup> above, the Principal Secretary, Health and Family Welfare Department Government of Kerala has informed that the Head of the Institution is competent to issue notification under the Right to service act. The Principal Secretary has also given direction to issue notification under Right to service regarding the Pre-Conception and Pre-Natal Diagnostic Techniques (Prohibition of Sex Selection) Act immediately.

In exercise of the powers conferred under Section 3 of the Kerala State Right to Service Act 2012, the Director of Health Services hereby issue the order regarding the services under PCPNDT act.
