Sealed quotations super scribing the name of work are invited from ANERT empaneled agencies for the work of conversion of Off Grid Solar Power plant to On Grid Solar Power Plant, as per the details of work and conditions listed below. This quotation notice and format of undertaking can be downloaded and the same can be duly filled and quoted in declaration part (page 3) and submitted along with covering letter, documents requested & proposed AMC Charges, by hand/ or by way of post/courier to Managing Director, KSIDC, Keston Road, Kowdiar, Thiruvananthapuram-695003, so as to reach this office on or before 7-08-2020 (2:00 PM) .The Quotations will be opened at 3:00 PM on the same day.

Terms & Conditions

- 1 Attested copy of the proof of the agency being approved by ANERT shall be produced along with quotation.
- 2 Only ANERT empanelled agencies having an experience in similar works shall participate .Preference will be given to those who have done a minimum aggregated capacity of 500 kw which includes at least one plant having a minimum of 30 kw successfully. Proof to be submitted later when called for by KSIDC.
- 3 The quote should be made only after inspecting the plant installed at KSIDC office for assessing the work to be carried out. (Interested agencies may send an email to enquiry@ksidemail.org for scheduling site visit)
- 4 Only valid licensed A class Electrical wiring contractors to be entrusted for the aforementioned work.

- 5 The agency must have valid grading certificate issued by CRISIL Ltd.
- 6 Registration certificate of the firm which is issued by registrar of companies or other competent authority under which firm is registered has to be submitted. The details of the bidder should match with registration certificate.
- 7 The Agency should have a valid GST registration (proof to be submitted).
- 8 The selected agency should provide services facility for warranty items free of cost for the warranty period and also arrange for services of non warranty items on payment basis.
- 9 The selected agency should coordinate with KSEB for obtaining feasibility certificate in favor of KSIDC before commencement of work.
- 10 The On Grid inverter having a minimum warranty of 5 years shall be procured by the selected agency from ANERT approved manufacturer.
- 11 Making available net metering facility/ energy meters of required standards through the Distribution Licensee or procurement and testing of energy meters shall be the responsibility of the selected agency. If KSEB is not supplying meter and for this actual additional payment will be made towards cost of meter and calibration.
- 12 Work shall be carried out as per prevailing rules of Electrical Inspectorate and KSEB.
- 13 Rearrangement required to club with existing wiring system shall be done by the selected agency through licensed contractor.
- 14 Work shall be treated as complete only on getting successful grid connection from KSEB and monitoring the flawless performance for a week.
- 15 All statutory payments to Electrical Inspectorate and KSEB are to be made in the name of MD, KSIDC, and shall be reimbursed on production of original bills.
- 16 Contract amount may be quoted on percentage system and to be returned along with quotation form with all conditions duly accepted.
- 17 AMC charges for the Solar system including non warranty items, after successful conversion of Off Grid Solar Power plant and Commissioning of On Grid Solar power plant for succeeding 5 years may also be furnished with conditions if any, along with quotation.
- 18 The quoted amount has to be furnished in figures and words and should specify whether it is below or above the estimate.
- 19 Payment conditions will be as per KSIDC rules prevailing at that time.
- 20 Any additional condition from your side for the proper implementation can be given along with the quote.

- 21 KSIDC may amend the Quotation notice as per requirements or wherever KSIDC feels that such amendments are absolutely necessary.
- 22 Quotations received after due date and time will not be considered.
- 23 KSIDC has the sole authority to reject any quotation and to cancel the quotation without assigning the reason
- 24 KSIDC at its discretion may or may not extend the due date and time for the submission of quotation. Hence bidders are requested to visit KSIDC website regularly for such updates.
