ORDER

The Managing Director, Kerala State Industrial Development Corporation (KSIDC) Limited as per letter read as 1st above, has put forth a proposal regarding the Terms of Reference for the development of an Environmental, Social & Governance (ESG) Policy to promote ESG investments in the State. Prior to the implementation of the ESG policy, an in-principle decision was taken to constitute a Committee to conduct expert study regarding the ESG investments in the state. Accordingly the Managing Director, KSIDC as per letter read as 2nd above, submitted proposal for the the constitution of an expert committee.
